The State Bank of Table Rock was chartered in 1885 in Table Rock, Nebraska, a town of 288 people. Robert and Ethelann Stillinger purchased the bank in 1958 from Mariam and Guy Bonham. They purchased the State Bank of DuBois in 1968 from the Phanetta Bohm/Farwell family, which was held under a one-bank holding company. Due to illness, Robert passed management of the bank to his daughter and son-in-law, Rick and Bobbie Stillinger-Kunze in 1990. There are currently three generations of the Stillinger family involved in the organization.

A merger of the Table Rock & DuBois bank charters was completed in 1994 under DuRoc Investment Company, the DuBois bank's holding company. The State Bank of Table Rock operated at these two facilities until 1995. Due to having many customers in nearby towns and wanting to provide local service to them, the board of directors decided to expand their operation. They opened a branch in Pawnee City, Nebraska, in 1995, and a branch in Humboldt, Nebraska, in 1997. In 2008 the bank decided to expand and diversify its markets and opened a branch in Roca, Nebraska, which is 6 miles south of Lincoln, Nebraska.

Our Board of Directors and staff promise to continue to strive to be the best at what we do; offering the best and latest in retail banking and insurance services. Over the past year, we have added many new online features to the banking side, such as Mobile Deposit (scan your check, deposit from your smart phone), Mobile Bill Pay, and Business Remote Deposit Capture (business deposit of checks from convenience and comfort of your office). We have gone from batch processing of our ATM & Debit Card services with Shazam to live streaming of balances for quicker and complete up-to-date account balances on our internet banking software.

Community Insurance Group began as R.H. Stillinger Insurance Agency. It is now The State Bank of Table Rock's full-service insurance agency. In 2000, the Hofmann Agency in Pawnee City was purchased and combined with the Stillinger Agency, and the name was changed to Community Insurance Group in 2005. The Agency is staffed with six full-time agents that write auto, home, farm, crop insurance, commercial, life and health insurance. It has locations in both Pawnee City and Tecumseh. Because it is an independent agency, the agents at Community Insurance Group are able to write policies with more than 35 different companies. This allows them to find the best possible coverage and rates for their customers.
