Beware of Counterfeit Postal Money Orders

We have believed that living in the rural mid-west that we did not need to be as concerned about fraudulent scams. That is no longer true. Particularly with the increased usage of EBay and other Internet sites in so many of our homes, we are not as insulated as we used to be. It seems that the crooks work very hard to steal our hard earned money.



The use of counterfeit Postal Money Orders (PMO) is on the rise and the con artist's are producing very good copies making it very hard for consumers to tell the authentic Postal Money Orders from the fakes. Domestic PMOs cannot exceed a value of \$1000 and have watermarks, security threads and a rainbow of inked patterns. Common counterfeit values are between \$750 and \$950.

The average counterfeit money order scam works this way. The seller of a product is sent fraudulent PMO(s) worth more than the amount of the item. The buyer then asks the seller to send extra cash back with the product. This is also known as a Nigerian Scam because many of these types of scams have originated in Nigeria or other African nations.

But there are several steps you can take to protect yourself. Know who is giving you the PMO. Be very careful of cashing a check and sending part of the balance back. Trust your instincts. If it sounds "too good to be true," be very careful.

Even with the speed of today's banking system, it can take 10 days to as long as 2 or 3 months before we are notified that a PMO is counterfeit. Fraudulent Canadian Money Orders can be returned for up to two years.

As your bankers, we try our best to be another line of defense between you and those trying to defraud you.

Caution:

It's best to **NEVER** use your **DEBIT CARD** to purchase items on the internet! If you change your mind about the purchase or realize you've been scammed it's much harder to reverse or stop than if you've used a credit card. A debit card gives them access to your checking account and **ALL** of your funds. If you have to cancel or block your card it can be expensive as well as inconvenient.

Chocolatey Chocolate Chip Cookie Cups

Ingredients

- 1 (16.5 oz) package Nestle Toll House Refrigerated Chocolate Chip Cooke Bar Dough
- 1 cup Nestle Toll House Peanut Butter & Milk Chocolate Morsels

Directions

1. Preheat oven to 350 degrees F. Grease or paper-line 24 mini-muffin cups.
2. Place squares of dough into prepared muffin cups; press down lightly in center to make a well.
3. Bake for 9 to 11 minutes or until edges are set. Cool in pans on wire racks for 5 minutes; remove to wire racks to cool completely.
4. Microwave morsels in small, heavy-duty plastic bag on medium-high power for 30 seconds; knead until smooth. Microwave at additional 10 to 15 second intervals, kneading until smooth. Cut tiny corner from bag; squeeze chocolate into each cup.
