attending college in Lincoln.



Fake Bank Site preads Malware

The Office of the Comptroller of the Currency announced a warning November 17, 2011 about HelpWithMyBank.com, an illegitimate website pretending to offer consumer information about bank accounts and loans.

Once a consumer visits the website HelpWith-MyBank.com, it redirects the individual to a legitimate consumer information site called HelpWithMyBank.gov, attempting to convince users they are connecting to a legitimate site.

However, because the individual is connecting to the fake site first before the redirect it is believed to expose the consumer to malware.

The vice president and senior advisor of risk management policy for the American Bankers Association says that these so called typo-domains or domains that claim to offer legitimate consumer information in attempts to fool consumers into clicking malicious links are not new. However, there is little the banking industry can do to prevent these types of sites from showing up. It is very easy for hackers to register malicious sites under existing domain name systems. It is said that anywhere from 2,000 to 4,000 fake websites exist online on any given day.

The ABA has announced plans to get more involved in steps to protect the image of banking entities by regulating how sites affiliated with financial institutions and financial -services providers are registered. The additional measures proposed would be to have the URL be .bank. This would create a more protected environment and would help protect consumers from being fooled into visiting malicious sites.
