Data Destruction, LLC was formed early this year by Jeremy Marteney and Jesse Osborne. The idea generated from numerous customers




asking me over the course of my 15 years working with computers in the area as to the best way to destroy computer hard drives to protect business information as well as personal data for home users. A few months of research and planning led us to the idea of a mobile data destruction company.

We located a Michigan company that manufactured a shredder for this purpose and put together the business plan. A couple months later our 1300 pound shredder arrived and was mounted in a trailer with a 5000 watt generator. It is capable of shredding up to 90 hard drives an hour and also will do cell phones, tapes from tape drives, pda's and many other devices.

Since it is fully powered by the generator, we can pull right up to your house or business and you can watch the devices get destroyed. You are then provided with a certificate of destruction that documents what was shredded. We have since done jobs from Northeast Kansas to Lincoln, Nebraska and for customers ranging from home user to law firms, law enforcement agencies, insurance companies, schools and hospitals. Costs range by quantity but single drives are \$20 and cell phones and smaller devices are \$8 with the price scaling down by volume.
